BI-MONTHLY MEETING OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF BERLIN, CAMDEN COUNTY, NEW JERSEY, WAS HELD IN THE CONFERENCE ROOM OF THE SCHOOL BOARD ADMINISTRATIVE BUILDING, 225 GROVE AVENUE, WEST BERLIN, NEW JERSEY ON MONDAY NOVEMBER 23, 2009 AT 6:30 P.M.

Mayor Magazzu opened the meeting and stated that pursuant to the requirements of the Open Public Meetings Law, notice of this meeting was advertised in the Record Breeze and posted on the bulletin board.

All in attendance joined in the Salute to the Flag.

### **ROLL CALL**

Jackson, Chief Of Police.

### **GOOD AND WELFARE #1**

Motion by Council President DiGangi, second by Councilman McIntosh to open the meeting to the public. Motion carried by voice vote, all present voting in the affirmative. Mayor Magazzu opened the meeting to the public for comments.

Dan Neil, North Rose Lane said that his taxes have gone up \$1,700 and would like to know what this money has been spent on.

Mayor Magazzu replied that the majority of the money goes to the School, and then a portion goes to the Township and the County. The Mayor remarked that we no longer receive State Aid also. Mayor commented that you can get copies of the budget to view any spending from the School, Clerks Office and the County.

No more comments were to be heard.

Motion by Councilman Batten, second by Councilman McIntosh to close the meeting to public. Motion carried by voice vote, all present voting in the affirmative. Mayor Magazzu closed the meeting to the public.

### **DEPARTMENTAL REPORTS**

### A. CHANGE ORDERS AND VOUCHERS

No change orders or vouchers to report at this time.

### B. **ENGINEER'S REPORT**

1. TRAFFIC SIGNAL AND GEOMETRIC IMPROVEMENTS AT THE INTERSECTION OF COOPER ROAD AND TAUNTON AVENUE

(KEI #393BT0203): I have been informed that the Freeholders have not awarded the Contract and are waiting for N.J.D.O.T. to accept the bids. Therefore, no construction date has been established by the County.

Mayor Magazzu has informed me that Freeholder Leonard's aide had stated, at a recent Mayors Association meeting, that the County will pay for police directors, when the project is State funded. I had requested that the County Engineer confirm this understanding, especially for this project. He informed me that he was not aware of this policy.

2. SIDEWALK ALONG N.J.S.H. ROUTE 73, EDGEWOOD AVENUE TO JACKSON ROAD, (N.J.D.O.T. FY 2008 AND FY2009 FUNDING - \$320,000.00): As directed by the Pinelands Commission, we are preparing the necessary documents for stormwater management and wetlands.

I have also obtained copies of the N.J.D.O.T. Construction Plans, which depict wetlands limits. We intend to use the N.J.D.O.T. plans, when addressing the wetlands issues.

3. RESURFACING OF MT. VERNON AVENUE-FRANKLIN AVENUE TO MINCK AVENUE [N.J.D.O.T. FY2010 MUNICIPAL AID FUNDING - \$180,000.00] (KEI #506BT0509): The N.J.D.O.T. has announced the allotment of \$180,000.00. The application requested \$254,000.00 (\$221,147.50 estimated construction cost plus \$32,852.50 for inspection and materials testing). The N.J.D.O.T. funds are reimbursed to the Township. The N.J.D.O.T. reimburses 75% of the eligible funds after the award of the construction contract and 25% after their acceptance of the construction.

The following is an estimate of the costs:

a.	Construction Cost	\$221,147.00
b.	Engineering Cost	\$ 26,000.00

\$269,147.00

I recommend that the Governing Body consider authorizing our office to perform the necessary engineering and prepare the bid documents so that bids can be received in late 2009/early 2010. Typically, opening bids, during this period of the year, results in the receipt of the most competitive bids as the contractors are developing their workload for the upcoming construction season.

If the Township is not, financially, able to afford the entire cost, we recommend that the Proposal be structured to include a Base Bid and Alternate Bid(s) to allow the Governing Body to select the limits of the project, based on the availability of funds.

The N.J.D.O.T. has submitted a letter to Mayor Magazzu, informing her that funding was not allotted for the improvements to Hazel Avenue (Priority No. 2).

### 4. PROPOSED MUNICIPAL BUILDING, N.J.S.H. ROUTE 73 AND DAY AVENUE (KEI# 422BT0804):

- a. <u>Site Work</u>: The general contractor expects the construction of the parking lot to be completed within three weeks, excepting for the surface course. The surface course will be constructed after the building construction has been substantially completed.
  - I would note that the existing parking area, along the front of the building, will only be seal coated.
- b. <u>Irrigation System:</u> The Governing Body has decided to address this matter, at a later date. Piping has been installed to allow for the irrigation piping to be placed, inside the pipe, without requiring the disturbance of the pavement, for the proposed parking area.
- c. <u>Landscaping:</u> The Governing Body has determined that this work will be completed after the completion of the building.
- 5. PURCHASE AND/OR LEASE OF SENIOR CITIZENS BUS, [C.D.B.G. YEARS 30 AND 31 FUNDING- \$60,500.00+/-] (KEI# 165.01BT0209): It is anticipated that the bus will be delivered by the end of 2009.
- 6. HADDON AVENUE STREETSCAPE IMPROVEMENTS (KEI #430BT1104 AND #431BT1104):

- a. Phase 2 Franklin Avenue to Bate Avenue (N.J.D.O.T. Discretionary Fund \$200,000.00) (KEI #431BT0105): As discussed, the Office of Local Aid has advised our office that the N.J.D.O.T. Chief Financial Officer determined that the project is closed and the funding is no longer available to reimburse the \$3,180.00.
- b. Future Phases Jefferson Avenue to Franklin Avenue and Walker Avenue Bate Avenue to Lucas Avenue (FY2004 Transportation Enhancement Program and FY2005 SAFETEA-LU) (KEI #29-430BT1104): As reported, the Governing Body had decided not to accept the funds and requested that the project be bypassed to the future time when the Township would be in the position to bond the project.

### 7. **N.J.D.O.T. MATTERS**

- a. <u>Punch List Items Sanitary Sewer Construction, N.J.D.O.T. Route</u>
  <u>73 Project:</u> To date, I have not received any response from the N.J.D.O.T., regarding the issue. I recommend that the Governing Body consider allowing me, or Ms. Zoll, to contact the N.J.D.O.T. Commissioner's Office to request his assistance.
- b. Planting of Trees along the Rear of the Retail Center, Along the N.J.D.O.T. Ramp, Connecting Oak Avenue to Taunton Avenue (KEI #484BT0108): As directed by Mayor Magazzu, I have provided her with the phone number for the management company, since they will not respond to my phone calls.
- c. Request for No U-Turn at Median Opening along Route 73 at the Proposed Driveway for the Golden Corral Restaurant: I believe that the applicant for the proposed Golden Corral restaurant has received the N.J.D.O.T. Highway Access Permit. I will request the applicant to submit a copy of the Permit to see what position the N.J.D.O.T. has taken, regarding the approved turning movement through the median opening. I will inform the Governing Body and Police Chief once I have reviewed the Permit.
- 8. <u>CAMDEN COUNTY OPEN SPACE, ROUND 10 APPLICATION</u>
  (KEI #487BT0208): Mr. McGee is discussing the redesignation of funds with Mr. Jack Sworaski from the County. Mr. McGee has also received prices for the performance of the work.

### 9. **SANITARY SEWER ALLOCATION**:

a. Sanitary Sewer Extension along Edgewood Avenue and Allied Parkway: Last month, I informed the Governing Body of the conditions in which The Pinelands Commission would be willing to consider the connection of the existing buildings to the Township sanitary sewer. Mr. McGee has informed me that these buildings are, already, connected to the Berlin Borough water distribution system. I have informed The Pinelands Commission representative of the water connections and questioned if this would change their requirement that the buildings must connect to New Jersey American Water Company's water system. Once I receive a response, I will inform the Governing Body.

I have, again, requested the response from the Pinelands staff, regarding the requirement for the existing buildings along Edgewood Avenue and Allied Parkway to N.J. American Water distribution system if they are already connected to the Borough water system.

The Pinelands Commission representative had stated that they would possibly consider the extension of sanitary sewer to these buildings, only if they connected to the New Jersey American Water system.

b. <u>Amendment to the Wastewater Quality Management Plan:</u> As suggested by Mr. Kricun, P.E. of the C.C.M.U.A., the Governing Body has decided to wait until the Spring of 2011 to push this matter, since he feels that additional capacity will be available, resulting in no need for the Township to pay for upgrades to the C.C.M.U.A. conveyance system.

Future development, within the Township, will be restricted until the allocation issue is resolved.

10. FLOODING OF PROPERTIES ALONG VETERAN'S AVENUE, BETWEEN FISKE AND WALKER AVENUES: We have submitted our findings and recommendations to the Governing Body. The Governing Body mentioned that, possibly, the construction of the built-up bituminous drives could be included with a future street improvement program.

#### 11. FORMER MUNICIPAL BUILDING SITE, BATE AVENUE

**(KEI #233.01BT1106):** As discussed with the Governing Body, I have requested the scheduling of a meeting with the N.J.D.E.P. Green Acres to discuss the removal of the recreation encumbrance from the parcel and designating another parcel in the Township.

I believe that the Governing Body may be discussing the possible designation of land at the elementary school site for a playground with the School Board and Administrator.

12. **ALTERNATIVE ENERGY SOURCES:** Over the past several months, we have mentioned that there are various grants, rebates and incentives which are being offered by the State agencies.

Under the Local Energy Audit Program, the Township must supply the State with information, regarding energy costs and usage for the public facilities. The State will have their consultant perform the energy audit and provide a listing of recommended improvements. If the Township commits to the implementation of the recommended measures and improvements, the State is providing 100% up-front funds for these items.

Lately there has been an increased interest in the Program, which has resulted in a backlog in the performance of the audits. Therefore, I recommend that the Township pursue the performance of the audit, as soon as possible. We would be glad to assist the Township with the gathering and submission of the required documentation, which is with the initial submission.

The N.J.B.P.U. is also providing the following programs:

- a. Residential Energy Efficiency Programs for existing homes
- b. N.J. Energy Star for new homes
- c. N.J. Climate Choice Home Pilot for developers of new homes
- d. N.J. Smart Start Building Projects for new construction, renovation, and equipment replacement for commercial, industrial, and municipal buildings (\$500,000.00 max/utility/year)
- e. Pay for Performance (for larger municipalities) for buildings using over 200 KW average annual peak.
- f. Direct Install Program (for smaller municipalities) this program is used to implement the measures, which are listed in the Energy Audit.
- g. 2009 Renewable Energy Programs provide for rebates through the Renewable Energy Incentive Program (REIP) and SREC
- h. Community Partners Program provides for up to \$4,000.00 for municipalities to provide support, outreach, and education to the public

We would be glad to provide additional information, regarding any of these programs, if there is any further interest by the Township.

### 13. AMENDMENTS TO LAND USE AND ZONING ORDINANCES:

a. <u>Tree Protection Ordinance:</u> The Planning Board intends to review the current ordinance and submit recommendations, in the near future. I

recommend that Council President DiGangi and/or Mr. McGee discuss this matter with Planning Board Chairman Simone, prior to the Planning Board taking any action, since they have created a list of possible amendments to the ordinance.

- b. Regulations for Wind, Solar and Other Alternative Energy Facilities: It was anticipated that the Governor would be signing the legislation, this month, which would establish these facilities as "inherently beneficial uses". It is my understanding that the legislation requires the N.J.D.C.A. to develop model regulations. Therefore, I recommend that the Township wait to see if the Governor signs the legislations and, if signed, use the model regulation for a guide.
- 14. <u>MULTI-YEAR CAPITAL IMPROVEMENT PROGRAM:</u> We strongly recommend that the Governing Body implement the long term plan for improvements to streets, recreation, storm drainage and management, sanitary sewer, alternative energy sources and energy efficient, public buildings, vehicles, equipment, etc.

We had, previously, prepared a recommendation report, which lists projects. If the Governing Body is interested, we will revise the report, to include alternative energy sources and energy efficiency/green improvements.

15. **CONVERSION OF TRAFFIC SIGNAL LIGHTS TO L.E.D.:** The County had sent a letter to all Mayors, informing them that they intend to request proposals for the conversion of the incandescent signal heads to L.E.D., which are more energy efficient. The RFP will include equipment, service and maintenance of the traffic signals, within the County.

The County had requested interested municipalities to submit a listing by October 29, 2009, of the locations and number of traffic signals for consideration for conversion to the L.E.D. heads. I question if the Township had responded to this request.

- 16. **PERFORMANCE SURETIES FOR DEVELOPMENTS:** The Township has received requests for bond reductions for the following developments:
  - a. <u>Kepple Carpet, Cushman Avenue:</u> We have inspected the site and issued an updated Punch List.
    - We recommend that the Performance Bond be reduced from \$68,737.20 to \$28,971.00, a total reduction of \$39,766.20.
  - b. <u>Pepé DiVentura, Proposed Retail Center, Cross Keys Road and Fairfax Avenue:</u> On September 10, 2009, we had recommended that the bond

be reduced from \$570,879.60 to \$230,560.80.

c. <u>Victory Lane Restaurant:</u> We have inspected the site and issued an updated Punch List.

We recommended that the Performance Bond be reduced from \$430,398.00 to \$21,300.00, a total reduction of \$409,098.00.

#### d. Montebello:

- 1) <u>Section 3a Clubhouse</u>: The developer has provided our office with a copy of the General Surety Rider, which reduced the Performance Bond amount to \$795,533.00, in accordance with Resolution No. 2009-164.
- 2) <u>Section 2a Copley Circle:</u> The developer has posted Performance Bond No. 5033561, for the amount of \$707,089.20, with the Township Clerk. The developer has distributed the Final Plat to the Township Officials for signature.

The limits of the various sections are being amended to coincide with practical construction sequences and to create sub-sections with lesser numbers of housing units for bonding purposes. The Planning Board Solicitor has determined that the shifting of section limits and further sectioning does not require any action by the Planning Board since final approvals were granted for the entire development.

e. <u>Sahara Sam's Indoor Water Park:</u> We have issued a Punch List and have met with the contractor several times. We are waiting for the contractor to request a final inspection.

Once all work has been satisfactorily completed and accepted, a two-year Maintenance Bond in the amount of \$305,008.20 must be submitted.

Mike McGee, Director of Public Works updated the progress of the Municipal Building stating that the sheet rocking was going up at this time. Mike commented that the resurfacing of the court were done and that he had heard from Jack from the County who stated that the other courts could not be done and that the funds should be used for another project. The directors suggested the mulching of Day Aves Playground.

### **POLICE DEPARTMENT**

Joe Jackson, Chief of Police and Emergency Management spoke about the County doing a group wide plan for our area. The Chief put three targeted area being the Walker Ave and the water Drainage issues along with the emergency generator back-up for the Municipal building and the fire department.

### MAINTENANCE/ZONING DEPARTMENT

Michael Laginestra noted that he had sent out the summons for the resident on Warren Avenue. Mike also spoke about an issue with Pinelands. A resident sold there property as Commercial with the Township map showing it as Commercial, but Pinelands map show the property as R-1. Mike noted that he would address the Planning and Zoning board on this issue.
