The proposal shall also be accompanied by all forms provided in the Proposal Section of the Specifications or to be submitted by the Bidder and listed in the Checklist. Bidders must comply with their State of New Jersey Department of Labor "Certificate of Registration" as required by the "Public Works Contractor Registration Act" and State of New Jersey Business Registration Certification issued by the State of New Jersey Division of Revenue as required by N.J.S.A. 52:32 - 44 and Public Law 2004, Chapter 57.
