#### POLICE REPORT

Chief Check reported the Department Stats, for December 2018

Total of 140 Motor Vehicle Summons, which include 2 for DWI, 44 Motor Vehicle Crashes, 61 Alarms calls. A total of 51 arrests, which include 3 for narcotics and 29 warrant services.

There was an increase of 1970 calls for service from 2017 to 2018, which include 197 MV Summons issued and 20 MV Crashes, there was also an increase of \$817.05 monies collected. There was a decrease of 135 alarms and 24 total arrests during this same timeframe. The increase in total calls for service and MV summons is directly related to manpower. The timely replacement of Ptl. Murray and Lt. Siderio after their retirements allowed the department to progress forward and I thank Mayor and council for that. The addition of the 18 full time officers will allow me to utilize a power shift with all rotations without sacrificing the detective unit or our community outreach efforts in 2019.

There were a total of 8 internal affairs investigations for 2018, 4 were citizen complaints, (3 were exonerated, and 1 is pending and outcome in 2019). 4 were administrative investigations, (3 were sustained, and 1 not sustained). The Internal Affairs summary report will be posted in the Municipal building and police department lobbies.

Officers completed all mandatory training and qualifications on all weapon systems as required by the Attorney General Directives, also random drug testing was conducted as per Attorney General Directive and all passed.

ORDINANCE 2019-1 OF THE TOWNSHIP OF BERLIN, COUNTY OF CAMDEN, AND STATE OF NEW JERSEY, REPEALING AND REPLACING ARTICLE VIII, ENTITLED "APPEALS," REPEALING AND REPLACING ARTICLE V, ENTITLED "ZONING BOARD OF ADJUSTMENT," AMENDING ARTICLE VI, ENTITLED "PROVISIONS APPLICABLE TO BOTH PLANNING BOARD AND ZONING BOARD OF ADJUSTMENT," AND AMENDING ARTICLE VII, ENTITLED "DEVELOPMENT PROCEDURES FOR PINELANDS AREA," OF CHAPTER 200 OF THE CODE OF THE TOWNSHIP OF BERLIN ENTITLED "LAND USE AND DEVELOPMENT"

WHEREAS, Chapter 200 of the Code of the Township of Berlin, entitled "Land Use and Development," guides the use and development of land within the Township of Berlin in accordance with and pursuant to New Jersey Municipal Land Use Law ("MLUL"); and

WHEREAS, Article VIII of Chapter 200 of the Code of the Township of Berlin, entitled "Appeals," outlines an appeal process from the Berlin Township Joint Planning and Zoning Board (hereinafter the "JLUB") to the Mayor and Township Council of the Township of Berlin; and

WHEREAS, the Mayor and Township Council (hereinafter "the Governing Body") have reviewed the existing provisions pertaining to an interested party's ability to appeal final JLUB decisions to the Governing Body; and

WHEREAS, the Governing Body has determined that the appeal process to the Governing Body needlessly burdens its time and resources, fails to provide finality to the land use appeal process, and that it is in the best interests of the residents of the Township of Berlin to repeal Article VIII of Chapter 200; and

WHEREAS, the Township does not operate a separate Zoning Board of Adjustment and Township's JLUB already exercises the combined powers of a Zoning

Board of Adjustment and the Planning Board pursuant to the provisions of N.J.S.A. 40:55D-1 et seq. and N.J.S.A. 40:55D-70 et seq.; and

WHEREAS, the Governing Body deems it advisable to repeal Article V, entitled "Zoning Board of Adjustment," of Chapter 200, amend Article VI, entitled "Provisions Applicable to Both Planning Board and Zoning Board of Adjustment," of Chapter 200, amend Article VII, entitled "Development Procedures for Pinelands Area," of Chapter 200, and repeal all other residual provisions pertaining to the Zoning Board of Adjustment pursuant to N.J.S.A. 4-:55D-25(c); and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the Governing Body is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Township by law.
