DEPARTMENT REPORTS

POLICE DEPARTMENT

Berlin Township Mayor and Council July Monthly Police Department Report

- Thank you for my appointment
- June 30, 2020 at noon Chief Len Check did his final walk out from the department.
- Up until this past Friday the police department was short 8 officers for patrol due to injuries, work restrictions and retirement. One officer returned to his night shift on 7/3/20.
 - I had to do some shifting around of personnel. Because of shortage, we no longer have a full-time detective Det Lex has be moved back to patrol to run a squad. Lt Silvestro is covering some of the detective work as well as handling many of the administrative details including, Internal Affairs, updating policies required by the Prosecutor's Office and NJAG, extra duty details, writing subpoenas', purging evidence, scheduling training, overseeing patrol, CJIS requirement... pretty much anything I throw on his desk.
- We had a 241% increase in firearms applications and permits. From Jan 1, 2019 to July 6, 2019 we processed 29 applications and permits. The same time period this year we have and are currently trying to process 99. I have been able to get one of the offices who is still rehabbing

after his surgery to start learning the firearms process. To conduct a thorough investigation can take a minimum two hours to sometimes two weeks, depending upon the applicant. So, as you may be able to image, we are experiencing a little delay.

- Good News Burglary: -85% MV Crash: -26% other traffic related issues are down by an average of 46%; even traffic summons are down This mainly due to the stay at home restrictions during the first three months of Covid. Less pedestrian traffic, less motor vehicle traffic
- To highlight some of the theft and fraud cases that are be investigated
 - \$8000 fraud from Red White and Blue through three months of investigation suspected identified and changed
 - o \$9000 bail scam that spans Florida and Canada still under investigation
 - \$3000 internet theft subpoenas and perseveration letters sent to Facebook and google.
 - Stolen motorcycle working with truck rental company to obtain id's
 - \$26000 employee theft suspect identified and charged
 - \$11K burglary/theft still working to obtain data from Google to close this case.
 - I mention all of these because we also had a \$40 theft from an elderly woman at a local convenience store – the officers worked just as hard on this case as they are doing with thousand-dollar cases. They were able to identify the suspect and have the victim's money returned to her.
- Our officers have assisted surrounding towns 6 times with protests against police as well as
 violations of the Governor's Executive orders. Even with protesters getting in their faces, telling
 them how they should be ashamed of themselves for being police officer our officers as well
 as every other officer there stayed calm and professional and allowed the protesters to express
 their freedom of speech.
- In another noteworthy incident one of our officers was investigating a suspicious motor vehicle. The female driver appeared to be upset. The officer spoke with her, not convinced when she told him she was fine. In the end he discovered that she was going to attempt suicide. She had a step stool, belt and tape. Plus, she had rearranged a swing set to give her the elevation that she needed. The officer convinced her to allow him to help her.
- I do want to thank the mayor for the email of support and confidence that she sent to the officer. I know sometimes the guys don't always respond, but I can tell you that it was greatly appreciated.
- I did receive a proposal from the officers to pursue permission to get loadbearing vest carriers aka out vest carriers. I have the proposal on my desk that includes photos of the carriers, the

cost savings as well as physical benefits to the officers. When they started this project, they were told that the vests were not to appear too militaristic.

WHEREAS resolution 2020-123 was passed by the Governing Body of Berlin Township on June 8, 2020 to permit temporary covid-19 outdoor dining and seating; and

WHEREAS the Governing Body wishes to amend resolution to the following:

- Item 12- Amend the permitted opening time from noon, each day, to 8:00 a.m. to allow for the serving of breakfast with the condition that no alcoholic beverages can be served before noon.
- Item 12- Amend the closing time, Sunday through Thursday, from 8:00 a.m. to 9:00 p.m, amend the closing time, Friday and Saturday, from 8:00 a.m. to 10:00 p.m.
- Item 3- If and when, indoor dining and seating becomes permitted, the limitation for the total number of indoor <u>and</u> outdoor seats will be limited to the number of the existing, available parking spaces, based upon the parking schedule in Section 340-95 of the Township Code.
- Item 14- Amend to limit the maximum, overall number of tents to four (4) and the maximum tent area to the area necessary to cover all dining seating up to a maximum of 1,800 square feet.
- Item 6- If the Governor does not eliminate the prohibition of indoor dining prior to November 30, 2020, all temporary outdoor dining and seating permits will, automatically, expire no later than November 30, 2020 unless the permit is extended or a new permit is issued by the Township.
- New Item 21- Add the restriction that the existing surface material, within the designated outdoor dining and seating area shall remain and not be altered, except where it is determined to be a safety issue and the proposed surface alteration is approved by the Township, prior to disturbing the existing surface(s).

New Item 22- No changes can be made to the original plans unless approved by the Township Engineer.
