ENGINEER AND DIRECTOR REPORT (is in back on the minutes)

POLICE DEPARTMENT

Department Stats, August, 2019

Total calls for service for August – 3,963.

Total of 280 Motor Vehicle Summons, 34 Motor Vehicle Crashes, 62 Alarms calls. Total of 79 arrests, which include 2 for narcotics, 6 assault, 6 shoplifting, 7 frauds, 4 disorderly persons, and 42 warrant services.

Lt. McVeigh is officially retired as of September 1, 2019. He refused any type of sendoff. We all wish him well in the next phase of his life.

SSO Sawyer resigned from his position as a school security officer. He took a position closer to his residence in Gloucester County.

SSO Wilson (Retired from Berlin Twp.) was hired as our new school security officer. As you may or may not be aware there has been a lot of movement within the department, with the recent retirements and the hiring of new full time and SLEO II officers. There has been a substantial increase in the activity of our officers contact stops, traffic enforcement, and criminal arrests. I would say the moral within the department is high with the influx of new officers.

We are coming to the end of our promotional process for Sergeant and Lieutenant and I would ask for the governing bodies support in filling the open supervisory positions in a timely manner.

We will continue to have officers present at the schools and on Franklin Ave for the remainder of this week.

PROPERTY MAINTENANCE / ANIMAL CONTROL

Joshua Shellenberger stated that he is currently working on the Mercantile Renewals and some vacant property issues. Josh commented that he has been in contact with the contractor of the old Golden Coral location and they are hoping to be open by mid-October so all the landscaping issues should be complete by then. He also has been dealing with raccoon issues on Centaurian Drive and as of today our shelter count is 27.

PROCLAMATION: OVARIAN CANCER AWARENESS MONTH

WHEREAS, Ovarian cancer is called the "silent disease" because its symptoms are often vague or subtle, and a woman's lifetime risk of getting Ovarian cancer is 1 in 72; and

WHEREAS, there is no early detection test for Ovarian Cancer, the leading cause of gynecological cancer deaths in the United States, and where each year, more then 22,000 women are diagnosed with the disease and approximately 17,000 die from it; and

WHEREAS, if it can be detected in its early stages, survival from Ovarian Cancer is 90-95 percent. However, the five year survival rate for the disease is only 28 percent because it usually is not detected until the later stages; and

WHEREAS, the Ovarian Cancer awareness campaign was launched nationwide by the Ovarian Cancer National Alliance, Washington DC, to promote public awareness of this silent disease. A visual aid was established by utilizing the recognized cancer ribbon logo, with the ribbon color in teal.

WHEREAS, The Susan Marie Rupp Foundation set as their mission to promote public awareness of this silent, deadly disease and its symptoms through their "teal ribbons of hope" Ovarian Cancer awareness campaign:
