PARK RULES AND REGULATIONS

- 1. The parks are open between 8:00 a.m. and 8:00 p.m.
- 2. The permit holder will be responsible for insuring that the grounds are left clean and in "as found" condition. Trash should be bagged and left at the curb with recyclables separated.
- 3. No alcoholic beverages are permitted.
- 4. Portable toilets must be provided at parks without facilities.
- 5. Any vendors must obtain the proper permits through the Township of Berlin.
- 6. The Township of Berlin reserves the option to require one or more Police Officers at said event with all costs borne by the permit holder. The Police Chief shall determine the number of officers required if any.
- 7. The Township of Berlin reserves the right to cancel and/or terminate a program if we determine that there is a clear and present health or safety danger to the public.
