MEETING OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF BERLIN, CAMDEN COUNTY, NEW JERSEY AT BERLIN TOWNSHIP MUNICIPAL HALL AUGUST 10, 2020 AT 5:30 PM

(Meeting done by telephone due to Coronavirus)

Mayor Magazzu opened the meeting by telephone and stated that pursuant to the requirements of the Open Public Meetings Law, notice of this meeting was advertised in the Courier Post, Record Breeze and posted on the bulletin board.

All in attendance joined in the Salute to the Flag.

DEPARTMENT REPORTS

ENGINEER / PUBLIC WORKS REPORT

A. CHANGE ORDERS AND VOUCHERS

None at this time.

B. ORDINANCE AND RESOLUITIONS

1. AMENDMENT TO INTER-MUNICIPAL SEWER AGREEMENT WITH VOORHEES TOWNSHIP

I recommend that the Governing Body consider authorizing the Solicitor to work with Voorhees Township to amend the current sewer agreement to increase the sewer flow from lots within the southwest portion of Voorhees Township while assessing all previous and future allocation to Voorhees Township for this area.

2. AMENDMENTS TO CHAPTER 280, SOLID WASTE

I recommend that the Governing Body consider introducing an ordinance to amend Chapter 280 to address the necessary revisions to address the current listing of acceptable

recyclable items, delete the collection recyclables for commercial establishments, along with other necessary revisions.

3. AMENDMENTS TO LAND DEVELOPMENET AND ZONING CODES

I recommend that the Governing Body consider requesting that the Planning Board review the current codes for updates and revision to be consistent with current standards. An example of a matter, which is necessary for every development application, is the requirement for developments to use high pressure sodium site lighting. The Planning Board must grant a waiver to allow developers to use the more efficient and effective LED site lighting. Another matter, which is current, is addressing possible permanent (seasonal) outdoor dining, at eating establishments.

C. ENGINEERING

1. <u>IMPROVEMENTS TO CLARENCE AVENUE, PARTIAL N.J.D.O.T MUNICIPAL AID FY 2018</u> <u>FUNDING-\$210,000</u>

It is expected that the Gambale Concrete, LLC will be commencing with construction within the next couple of weeks. I believe that the Fire Commissioners will, formally, request that the contractor widen the driveway to the fire house, along First Avenue, to allow for easier maneuvering of the fire apparatus. If so, it will be necessary for the Governing Body to pass a resolution, approving a change order to include this work in the contract. I recommend that the necessary funds be allocated to cover the consulting inspection work for this project.

2. IMPROVEMENTS TO SPRUCE AVENUE, PARTIAL N.J.D.O.T FY 2019 FUNDING- \$186,000

Charles Marandino, LLC has commenced with the construction. All necessary roadway easements and consents to enter has been granted by the respective property owners. I recommend that the necessary funds be allocated for the consulting inspection services for this project.

3. <u>IMPROVEMENTS TO DAY AVENUE, ROUTE 73 RAMP TO CLOVER AVENUE (N.J.D.O.T FY</u> 2020 FUNDING- \$150,000)

I have requested that the necessary funds for the consulting land surveying and CAD drafting of the existing conditions and construction plans be authorized, in the immediate future, so I can perform the engineering design and prepare the bid documents. I intend to include this project with a street improvement program, which includes those streets in which funds have been allocated for improvement.

4. APPLICATION FOR N.J.D.O.T FY 2021 FUNDING

The application for the "Improvements to Various Streets" was submitted to the N.J.D.O.T, requesting \$731,000 for the improvements to the following streets:

a. Oak Avenue-N.J.D.O.T. Ramp 'A' at Route 73 to 80' Past Clover Avenue	\$198,500
b. McClellan Avenue-Haddon Avenue to Krumm Avenue	\$191,000
c. Krumm Avenue-McClellan Avenue to Franklin Avenue	\$341,500

It is expected that the announcement of the projects will be made by the end of 2020. Since the N.J.D.O.T limits the amount of funding, if successful, only a portion of the requested funding will be approved for these improvements. It is my understanding that the Governing Body will be able to use any allotted for one or more of the streets, which are included in the application.

5. CAMDEN COUNTY COOPERATIVE FOR THE PURCHASE OF ROAD SALT

The County will be receiving bids in September, 2020 for the purchase of road salt for a one-year period with an option to extend the contract for an additional year. I have informed the County that the Township would like to participate in this contract for the purchase of road salt. I believe that, after the County awards a contract for this material, it will be necessary for the Governing Body to pass a resolution to enter into the County cooperative program. In the past, participation in this County co-op has resulted in the most cost-effective means for the purchase of road salt.

6. CAMDEN COUNTY COOPERATIVE FOR TRASH DISPOSAL

Due to the increase in the contract rate with Covanta for the option year of 2021 (an additional \$3.20, raising the unit price to \$83.15/ton), the participating municipalities have requested that the County receive bids for a new contract. Bids are scheduled to be received on October 6, 2020 for a contract period of up to five years. We are hopeful that Covanta will provide a better unit price, recognizing that the participating municipalities are committing to a long-term contract.

7. SPECTATOR SEATING AT THE BAND SHELL AT LUKE AVENUE RECREATION COMPLEX, PARTIAL FUNDING THROUGH CAMDEN COUNTY RECREATION ENHANCEMENT PROGRAM

The Public Works staff has assembled the benches and will be installing them, along with the concrete handicap accessway and station, in the near future.

8. INSPECTION OF THE BASKETBALL COURTS AT LUKE AVENUE RECREATION COMPLEX

On May 20, 2020, the inspector from the N.J. Green Acres Program inspected the municipal parks. They have noted that the surface of the basketball courts is in need of improvement (reconstruction). I recommend that the necessary funds be allocated for the reconstruction of the basketball courts surface, in the immediate future. This work could be included with the upcoming street improvements program in order to obtain a more cost-effective price.

9. 2021 CAMDEN COUNTY OPEN SPACE AND RECREATION ENHANCEMENT PROGRAM

Applications must be submitted by March 31st, 2021. The Governing Body may want to consider applying for these funds for the improvements to the basketball court surface at the Luke Avenue Recreation Complex. An application was submitted, in 2020 for the ADA improvements and expansion to the playground at the Luke Avenue Recreation Complex.

10. <u>AMENDMENT TO THE INTER-MUNICIPAL SEWER AGREEMENT WITH VOORHEES</u> TOWNSHIP

As a result of numerous requests, by Voorhees Township, to connect to the Berlin Township sanitary sewer collection system and several discussions between the municipal representatives, a tele-conference was recently held with representatives of the C.C.M.U.A, Berlin Township, and Voorhees Township. Generally, the terms of the amended agreement would be to permit an additional, average daily sewer flow of 13,200+/- gallons from the designated portion of southwestern Voorhees Township (vacant lots, lots with septics). The Berlin Township collection system is capable of handling this additional flow. The allocation for the entire flow, previously accepted flow (19,100 gpd), plus the additional flow, will be assessed to Voorhees Township. Berlin Township will collect the sewer connection fee and receive the annual sewer fee for all future, permitted connections within the designated area. If this proposal is acceptable to the members of the Governing Body, I recommend that they authorize the Township Solicitor to assist with the preparation/ review of the amended agreement.

11. REQUEST FOR INCREASE IN SEWER ALLOCATION

I have not received any final response from the C.C.M.U.A., regarding the request for their support for the increase in sewer allocation, which must be submitted and approved by the N.J.D.E.P. It appears that the Sonoma Trails residential development may be delayed for some time.

12. <u>REPLACEMENT OF C.C.M.U.A. INTERCEPTOR PIPE, HADDON AVENUE PUMPING STATION</u> TO EGG HARBOR ROAD

It is anticipated that the C.C.M.U.A will be authorizing an emergency contract for the replacement of the 8,400 L.F. of the interceptor pipe through Berlin Township. I believe that a majority of the work may be performed during the evening and early morning hours. The work may result in some inconveniences to the residents along those streets, in which the pipe is located. The C.C.M.U.A and the emergency contractor will be meeting with Township Officials, prior to the commencement of the construction, to discuss the proposed construction.

13. NEIGHBORHOOD PRESERVATION PROGRAM, OLD WEST BERLIN SECTION

Mr. Conklin has informed the Governing Body of the award of NPP funds to the Township. He has requested that a meeting be scheduled to discuss the spending of the funds for the selected projects.

14. CAMDEN COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

I am not aware of the status of funding through this program. The Township had applied for funds for the ADA improvements/ expansion of the playground at the Luke Avenue Recreation Complex.

15. N.J. TRANSIT BUS SHELTERS

No update to report.

16. MONTEBELLO AGE-RESTRICTED RESIDENTIAL DEVELOPMENT

a. Acceptance of the Pumping Station by the Township

The developer is very near or may have completed the necessary improvements to the pumping station. I would expect that the developer will be requesting that the Governing Body consider accepting ownership and operation of the pumping station, in the immediate future.

b. Replacement of Concrete Sidewalks Throughout the Development

The developer has hired a second expert (forensic) engineer to observe the condition of the sidewalk. The engineer has stated that an evaluation should be based on structural integrity and not aesthetic conditions. I will be meeting with the developer's representative on August 12, 2020 to discuss the matter.

c. Release of Performance Bonds

It Is my understanding that the developer has applied for building permits for the last available lot within the development. An HOA representative has contacted me with to inform me that they have submitted their expert's report, listing the necessary corrective work. I believe that the various matters should be discussed with the Governing Body and Township Solicitor, in the near future and in advance of the developer requesting the release of the bonds.

17. <u>TOWNSHIP-OWNED BATE AVENUE SITE (FORMER MUNICIPAL BUILDING AND ADMINISTRATIVEBUILDING)</u>

I continue to recommend the demolition of the existing building. It is my understanding that the market for housing has greatly improved, over the recent year. I recommend that consideration be given to the re-zoning of the block and the redevelopment plan be amended to allow for the desired residential development of the Township-owned and adjacent, privately-owned lands.

18. TOWNSHIP-OWNED PROPERTY AT 191 MCCLELLAN AVENUE; BLOCK 521, LOT 19

We continue to strongly recommend that this building be demolished, in the immediate future.

19. <u>IMPROVEMENTS TO WATER DISTRIBUTION SYSTEM-BERLIN BOROUGH WATER DEPARTMENT</u>

No update to report.

20. STORM DRAINAGE IMPROVEMENTS

- a. Lester Avenue Drainage and Stormwater Management
- 1) <u>Phase 1- Construction of Storm Inlets, Piping and Stormwater Management Facility at the Low-Point.</u>

We have not completed the design for this project as we were hopeful about receiving supplemental NJDOT FY 2020 funds but were unsuccessful. I will complete the design for the limited improvements, based on the available funds, which have been allocated for the project.

2) <u>Phase 2- Extension of Storm Drainage to the Existing Stormwater Management Facility at the Luke Avenue Recreation Complex</u>

No update to report.

b. <u>Kelley Drive Stormwater Basin Reconstruction.</u>

No update to report.

c. Mt. Vernon Avenue at the Elementary School

No update to report.

d. <u>Storm Drainage Issues Within the Southwest Portion of the Township.</u>

No update to report.

21. TAX MAP AND ZONING MAP REVISIONS

I believe that the consulting engineer has completed the necessary revisions to the Tax Map. I recommend that the final version of the Zoning Map be completed and the Governing Body adopt the revised Zoning Map as the official Zoning Map.

22. <u>REQUET TO THE PINELANDS COMMISSION FOR THE REDESIGNATION OF ZONES WITHIN</u> THE PINELANDS AREA

I continue to discuss the matter with the Pinelands staff. At this time, they are waiting for my responses to this question.

23. STUDY FOR DESIGNATION OF TRUCK ROUTES THROUGHOUT THE TOWNSHIP

No update to report.

D. PUBLIC WORKS

1. OPERATIONS AND STAFFING

The crews continue to perform seasonal tasks and cleanup from the recent storms. I recommend that additional individuals be employed during the leaf collection and for snow plowing, when the need arises. The staff continues to practice safe distancing and other

procedures during the COVID-19 outbreak. The monthly collection of bulky waste items continues to be canceled, due to the virus outbreak. Many residents have been delivering their bulky waste items, along with other waste and recyclables items, to the Public Works Complex. The automated collection of trash, recyclables, and yard waste continues, as normal. The Department has purchased a truck-mounted magnet for pulling manhole lids and storm inlet grates, which will be safer than manually pulling these items. We will be using this equipment, in the near future.

We will be posting a request for applications to fill the mechanic's position. We are hopeful that we will be able to fil the position will a well-qualified individual.

2. REPLACEMENT OF BANNERS

We recommend that the seasonal/event banner be replaced as many are damaged, aged, and missing.

3. IMPROVEMENTS TO THE UNFINISHED ROOMS AT THE MUNICIPAL BUILDING

The HVAC units and electrical work should be completed within the near future. Once this work has been completed, it will be possible to complete the remaining improvements.

4. IMPROVEMENTS TO PUMPING STATIONS

We will continue to update the various components of the pumping stations.

5. <u>UPDATING OF VEHICLE FLEET</u>

I request that the Governing Body consider the allocation of funds to replace or rehabilitate deteriorated and aged vehicles, in the immediate future, so that the crews are able to efficiently and safely perform the various public works tasks. Some of the necessary upgrades to the fleet are rear load refuse vehicles, dump trucks, pick-up trucks and sewer utility truck.

6. REQUEST FOR CAPITAL IMPROVEMENTS AND PURCHASES

I continue to request additional staffing, capital improvements and equipment purchases to provide for the staff to perform the public works services and tasks. I would be glad to discuss the request with the members of the Governing Body and Chief Financial Officer.

SOLICITOR REPORT

Stuart Platt, Township Solicitor remarked that he has submitted his report and if anyone has any question please reach out to him.

PROPERTY MAINTENANCE / ANIMAL CONTROL

Josh Shellenberger stated that he has keeping up on the tall grass violations within town. Josh also informed the Governing Body that Smoothie King is opening up where Firehouse Subs was.

- a) Providing on-site security;

- c) Reducing school violence and other crimes;
- d) Providing a direct link to law enforcement;
- e) Improving the responsiveness of the Berlin Twp. Police Department based on community feedback;
- f) Improving school and community relations by addressing the concerns of the surrounding community that are caused by the school and its students; and

WHEREAS, in order to meet the above established goals and objectives, the Township shall provide two part-time Special Law Enforcement Officers ("SLEOs") to act as School Security Officers ("SSO's") for the Berlin Township public schools.

NOW, THEREFORE BE IT RESOLVED, in consideration of the mutual covenants and agreements set forth between the parties to this agreement, the parties agree as follows. (see attached)
