DEPARTMENTAL REPORT

ENGINEER & DIRECTORS REPORT

A. CHANGE ORDERS AND VOUCHERS

None at this time.

B. <u>RESOLUTIONS AND ORDINANCES</u>

1. <u>REQUEST TO RELEASE MAINTENANCE VOND FOR WALMART SUPERSTORE EXPANSION, 265</u> <u>ROUTE 73 NORTH</u>

I recommend that the Governing Body take the necessary action not to release the maintenance bond, as requested by the attorney for Walmart, until the necessary corrective work listed in my letter of August 4, 2021 has been satisfactorily completed by Walmart.

2. REQUEST TO REDUCE THE AMOUNT OF THE PERFORMANCE GUARANTEE FOR JMA

LANDSCAPING, 145 CROWFOOT ROAD

I recommend that the Governing Body consider taking action to reduce the amount of the performance guarantee for the roadway and site improvements from\$477,845.00 to \$198,683.77, amend the amounts of the maintenance guarantee to \$43, 688.75 and the inspection escrow to \$36,897.68. I, also, recommend that the applicant be required to submit a schedule, to the Township. for the completion of the remaining roadway and site improvements.

3. <u>REQUEST FOR THE RELEASE OF THE PERFORMANCE GUARANTEES FOR THE SITE</u> <u>IMPROVEMENTS (BASE COURSE) FOR SECTIONS 5 AND 6, MONTEBELLO AGE-RESTRICTED</u> <u>RESIDENTIAL DEVELOPMENT</u>

The consulting inspector is performing a final inspection of the improvements. Once I receive their report, I will submit my recommendation to the Governing Body for consideration for the requested release.

4. <u>REQUEST TO REPLACE LETTERS OF CREDIT WITH SURETY BONDS FOR THE MONTEBELLO</u> <u>AGE- RESTRICTED RESIDENTIAL DEVELOPMENT</u>

The Township Solicitor's Office has informed me that the developer has requested that the Township consider accepting surety bonds in place of the posted letters of credit for eight guarantees. If this request is acceptable to the Governing Body, I recommend that the amount listed on each surety bond be verified for accuracy by the Township.

5. <u>LED AND SANDBLASTED SIGNS FOR THE WELCOME SIGN AT THE CORNER OF HADDON AND LUKE AVENUES</u>

Due to the desired changes in the scope of the project, which will exceed the 20% change order threshold, it is my understanding that the Governing Body will be taking action to rescind the award of the current contract with KC Signs and Awnings of Aston, Pennsylvania. It is my understanding that this contractor is acceptable to this action. KC Signs and Awnings has informed the Township that they are a vendor with the Hunterdon County Co-op, where a contract could be awarded for the desired scope of work if the Township is a member of the Co-op.

6. <u>PROHIBITION OF VEHICULAR TRAVEL WITHIN THE SHOULDER OF COOPER ROAD AT THE</u> INTERSECTION WITGH HOPEWELL ROAD

As a result of a request and the investigation and determination by the Police Department, I believe that the Governing Body intends to take action to prohibit motorists from travelling within the shoulder of Cooper Road and, then, turning onto Hopewell Road. Since both roads are under the jurisdiction of Camden County, the County must approve the installation of the signage to prohibit this traffic movement.

7. INSTALLATION OF NEW IRRIGATION WELL PUMP AT THE LUKE AVENUE RECREATION COMPLEX

Bids were received on July 15, 2021 from three bidders, The bid prices range from \$6,290.00 to \$13,378.00. It appears that the lowest bidder may be determined to be a nonresponsive bidder. It is my understanding that the bid amounts of the other two bidders exceeds the available funds for this work. Therefore, I believe that the Governing Body will be taking action to reject the bids.

8. AMENDMENT TO THE STORMWATER CONTROL ORDINANCE

The Pinelands Commission is, currently, accepting public comments and has scheduled a public hearing on September 1, 2021, regarding the amendments to the stormwater management rules within Pinelands Area. I believe that it may be a couple of months before it will be necessary for the Governing Body to amend the ordinance in order to be consistent with the amended Pinelands rules.

9. AMENDING ORDINANCE FOR CHAPTER 320 FOR SNOW EMERGENCIES

I recommend that this section of the Code be revised to further clarify the issues, regarding snow and ice removal and prohibition of parking within the streets during a snow state of emergency.

10. ORDINANCE AMENDING CHAPTER 280, SOLID WASTE

I recommend that the Governing Body consider taking the necessary action, before the end of this year, to amend the Code to reflect current policies and procedures.

B. ENGINEER'S REPORT

1. <u>IMPROVEMENTS TO DAY AVENUE-NJSH ROUTE 73 TO CLOVER AVENUE (NJDOT FY 2020</u> <u>FUNDING)</u>

The NJDOT has notified the Township that the Township must award a construction contract before November 21, 2021. I was hopeful that this project could have been included in the same bid specifications with the improvements to McClellan Avenue. Since time is of the essence this project will be bid, by itself. I am, currently, completing the design and will forward it to the consulting CAD drafting firm for drafting of the construction plans, in the immediate future.

2. <u>IMPROVEMENTS TO MCCLELLAN AVENUE- HADDON AVENUE TO KRUMM AVENUE (NJDOT FUNDING- \$235,000)</u>

I recommend that the Governing Body allocate the necessary funds, in the immediate future, for the shortfall in the anticipated construction cost, consulting surveying fieldwork, CAD drafting and inspection so that the project can be bid for the upcoming Spring season of 2022.

3. NJDOT FY2022 MUNICIPAL AID APPLICATION

The application has been submitted to the NJDOT, requesting \$540,000 in funding for the improvements to Krumm Avenue- McClellan Avenue and Oak Avenue- NJDOT Ramp 'A' at Route 73 to 80 feet past Clover Avenue. It is expected that the NJDOT will announce the selected projects before the end of 2021.

4. <u>IMPROVEMENTS TO CLARENCE AVENUE-HADDON EVENUE TO VETERAN'S AVENUE</u> (N.J.D.O.T FY 2018 FUNDING)

Last month, the Governing Body approved the final change order and application for payment. Once the Township has received cancelled checks for payment to the contractor, we will submit the necessary paperwork to the NJDOT to close out the project and request the final reimbursement of the grant funds.

5. <u>IMPROVEMENTS TO SPRUCE AVENUE-CHESTNUT AVENUE TO CUSHMAN AVENUE (NJDOT FY 2019 FUNDING</u>

We expect Charles Marandino, LLC, the contractor, to complete the corrective work, in the immediate future. Once the punch list items have been satisfactorily completed, the final change order and voucher will be submitted to the Governing Body for consideration for approval and acceptance. I will, then, immediately follow with the submission of the necessary documents to the N.J.D.O.T for project closeout and request for the final reimbursement of State funding.

6. CAMDEN COUNTY OPEN SPACE AND RECREATION ENHNACEMENT PROGRAM

a. Round 19 Funding- Spectator Seating for the Band Shell

I recommend, if it has not already, that all necessary paperwork be submitted to the County to close out the project.

b. <u>Round 20 Funding- Improvements to the Gazebo at Luke Avenue Recreation Complex</u> Mr. Simone has informed me that the contractor has installed the metal roof on the gazebo the piers for the welcome sign.

7. NEIGHBORHOOD PRESERVATION PROGRAM- OLD WEST BERLIN SECTION

The welcome sign structure has been constructed by the Public Works staff, with the donated assistance from Mr. Dominick Dandrea. It is my understanding that the current contract for the LED and sandblasted signs will be rescinded and bids will be requested for the expanded scope of work. It is my understanding that the bids for the irrigation well will be rejected and bids or quotes will be received for said work. We intend to receive bids for the replacement banners and over-the-street ornaments and posts for the Haddon Avenue corridor, in the near future.

8. SHARED SERVICES FOR SOLID WASTE DISPOSAL FOR SELF-HAULING MUNICIPALITIES

The pre-bid meeting was held on July 21, 2021. It will be necessary to publish and send out an

addendum to all parties that have purchased the bid specifications before August 13, 2021. The bid opening is scheduled for August 24, 2021.

9. CAMDEN COUNTY RECYCLABLES PROCESSING CONTRACT WITH REPUBLIC/ FCR CAMDEN

The current contract expires in April, 2022. The County, as the lead agency, will be advertising to receive bids for the next contract period, in the very near future. It is anticipated that the until price for processing will increase, substantially, from the current price of \$5/ ton to approximately \$80 to 140/ ton. I recommend that the Governing Body allocate the necessary funds to cover the increased cost for these services.

10. CAMDEN COUNTY C.D.B.G PROGRAM

Funding was not approved for the improvements and expansion of the Luke Avenue Playground.

11. AMENDMENT TO THE INTER-MUNICIPAL SEWER AGREEMENT WITH VOORHEES TOWNSHIP

I defer this matter to Mr. Platt for any update

12. REQUEST FOR THE INCREASE IN SEWER ALLOCATION

I am still waiting for the final determination by the C.C.M.U.A staff and their consultant. Once we receive the position from the C.C.M.U.A, it will be necessary for the increase in allocation to be approved by the N.J.D.E.P.

13. <u>REPLACEMENT AND RE-LINING OF THE C.C.M.U.A. FORCE MAIN AND STREET</u> <u>RESURFACING, HADDON AVENUE PUMPING STATION TO EGG HARBOR ROAD</u>

It is my understanding that a majority, if not all, of the work has been completed by the CCMUA Contractor.

14. N.J. TRANSIT BUS SHELTERS

No update to report, at this time.

15. MONTEBELLO AGE-RESTRICTED RESIDENTIAL DEVELOPMENT

a. Request to Replace letters of Credit with Surety Bonds

Please see my comments in section B.4 of this report

b. Replacement of Concrete Sidewalk Throughout the Development

I issued my inspection report, dated April 21, 2021, to the developer. At the request of the developer, I met with their engineer on June 1, 2021 to, generally, discuss the contents of my report and observe the conditions of the concrete improvements and street pavement. I will be scheduling a meeting with the developer, in the immediate future, to discuss these matters and hopeful resolution.

c. Request for the Release of "Base Course" Performance Bonds for Sections 5 and 6

The developer has requested the release of the "base course" bonds for these sections. The consulting inspector is performing a final inspection of the improvements and will be reporting to the Township. Once I receive the report, I will submit my recommendation to the Governing Body.

16. DEMOLITION TOWNSHIP-OWNED BUILDINGS

I continue to recommend that the buildings at 176 Bate Avenue and 191 McClellan Avenue be demolished, in the immediate future. Mr. Simone is, currently, receiving updated quotes for this work.

17. POSSIBLE PROCUREMENT OF PROFESSIONAL PLANNING SERVICES

There have been discussions, over the past several years, regarding the possible amendments to the Central Business District, redesignation of zones within the Pinelands Area and updating of the land use and zoning codes. The Township has received proposals from two professional planners, which are being reviewed for possible selection of the individual.

18. UPDATES TO THE TAX MAPS AND ZONING MAP

The consulting CAD drafting firm continues to revise the tax maps, when requested by the Tax Assessor. The Zoning Map must be revised, in the immediate future. I believe that this matter will be addressed as part of the possible professional planning services.

19. IMPROVEMENTS TO BOROUGH-OWNED WATER DISTRIBUTION SYSTEM

No update to report.

20. STORM DRAINAGE IMPROVEMENTS

a. Kelley Drive Stormwater Management Basin

The rehabilitation of this basin must be performed, in the immediate future. Walmart has contributed funds for this work.

b. Lester Avenue Drainage and Stormwater Management

1) <u>Phase 1- Construction of Storm Inlets, Piping and Stormwater Management Facility at the</u> <u>Low-Point.</u>

I have not completed the design for this project as we were hopeful about receiving supplemental NJDOT FY 2020 funds but were unsuccessful. I will complete the design for the limited improvements, based on the available funds, which have been allocated for the project.

2) <u>Phase 2- Extension of Storm Drainage to the Existing Stormwater Management Facility at the</u> L<u>uke Avenue Recreation Complex</u> No update to report.

c. <u>Mt. Vernon Avenue at the Elementary School</u> No update to report.

d. <u>Storm Drainage Issues Within the Southwest Portion of the Township.</u> No update to report.

21. LOW PRESSURE SANITARY SEWER SYSTEM ALONG ALLIED PARKWAY AND EDGEWOOD AVENUE

Recently, there has been some interest by a few of the property owners along these streets to connect to the Township sanitary sewer collection system. At this time, it is anticipated that the individual property owners will bear the cost of the construction and, once completed, the force main pipe will be conveyed to the Township, becoming part of the collection system.

22. <u>STUDY FOR THE DESIGNATION OF TRUCK ROUTES THROUGHOUT THE TOWNSHIP</u> No update to report.

C. PUBLIC WORKS DEPARMENT

1. OPERATIONS AND STAFFING

The staff continues to perform the typical tasks for this time of the year. A seasonal employee Has be hired to assist the staff with the seasonal duties. I recommend that a listing of individuals, preferably Township residents, which are experienced and capable of operating snow removal vehicles and equipment, be created to provide for back up to the staff for the upcoming winter season.

2. UPDATING OF THE PUBLIC WORKS VEHICLE FLEET

Mayor Magazzu has informed me that a meeting will be scheduled, in the immediate future, with her and Mr. Davidson to discuss the replacement of the deteriorated and extremely aged vehicles so that the crews are able to efficiently and safely perform the public works tasks. The immediate needs are a rear-load trash truck, pickup trucks, small dump trucks and sewer utility truck. There is, also, a need to replace the aerial lift truck and street sweeper. As previously mentioned, it is questionable if there will be the necessary number of snow plow vehicles for the upcoming winter season to properly perform the snow removal tasks. It is important that these vehicles be ordered, immediately, as there is a shortage of these vehicles and long delay in receiving them.

3. REQUEST FOR CAPITAL IMPROVEMENTS AND PURCHASES

I continue to request additional staffing, capital improvements and equipment purchases to

provide for the staff to perform the public works services and tasks. Mayor Magazzu has informed me that these requests will be discussed at our meeting with her and Mr. Davidson.

4. IMPROVEMENTS TO THE SANITARY PUMPING STATIONS

A majority of the components for all of the pumping stations are aged and in need of repairs, replacement and/or upgrade. I believe that it may be necessary to allocate funds, in addition to the current capital funds, to complete the necessary improvements. We will discuss this matter at our meeting with the Mayor and Mr. Davidson.

5. IMPROVEMENTS TO THE FUELING SYSTEM AT THE PUBLIC WORKS COMPLEX

Mr. Simone is coordinating the installation and input of user information with the contractor.

6. DROP OFF OF WASTE AND RECYCLABLE AT THE PUBLIC WORKS COMPLEX

The recent COVID outbreak has resulted in an increase in the number and volume of drop offs of waste items. Even though the COVID restrictions have lessened, the drop offs continue to be greater than the pre-COVID period. Supervision and enforcement of these drop offs have become very important, to the point where it may be beneficial to assign a Public Works member to these tasks, to ensure that only acceptable items are being dropped off and placed in the proper materials containers.

SECOND READING AND PUBLIC HEARING ORDINANCE 2021-5 AMENDING AND SUPPLEMENTING CHAPTER 11 (CLAIMS APPROVAL AND PURCHASING) OF THE TOWNSHIP CODE TO REVISE REGULATIONS GOVERNING DIRECT DEPOSIT FOR TOWNSHIP EMPLOYEES.

WHEREAS, N.J.S.A. 52:14-15f authorizes local governments to mandate direct deposit for certain governmental employees effective after July 1, 2014; and

WHERAS, N.J.S.A. 52:14-15f does not require governing bodies to grant exemptions; and

WHEREAS, granting exceptions to the mandatory policy would not be cost effective.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Township of Berlin, in the County of Camden, a majority of the full authorized membership of this governing body affirmatively concurring as follows:

1. Section 11-1(A) (Payroll Account) of the Township Code is hereby repealed, and replaced with the following:

Section 11-1 Payroll Account

- A. There is hereby established a payroll account in the Township of Berlin. Each week after the payroll is processed, the Chief Financial Officer or designee shall prepare a payroll voucher. The voucher summarizes the total transfers required to be made for gross payroll, other requirements and the budget appropriations to be charged. The Chief Financial Officer shall make the necessary transfers from the current fund and sewer operating fund bank accounts to the payroll bank account. The Chief Financial Officer shall thereafter draw checks on the payroll account to the employees entitled to payment from the account. All payroll checks shall be in the form of Direct Deposit. Negotiable paper checks will not be issued after the effective date of this provision.

- 2. All other provisions of Chapter 11 remain in full force and effect.
- 3. All full-time employees and elected public officials who receive compensation from the Township of Berlin are mandated to have direct deposit of their compensation as of August 9, 2021 in accordance with Chapter 28 P.L. 2013, as defined under N.J.S.A. 52:14-15f(b).
- 4. All ordinances or parts of ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency.
- 5. If any provision of this ordinance is for any reason invalidated by superseding legislation or judicial decision, that provision shall be severed, and the remaining provisions shall remain in full force and effect.
- 6. This ordinance shall take effect following its final passage by the Mayor and Council and 20 days after publication as required by law.

- WHEREAS, JMA Landscaping has been developing the site, located at 145 Crowfoot Road, also known as Block 2103, Lot 14, and Crowfoot Road from Cooper Road to the site, as part of the original site plan approval granted by the Berlin Township Planning Board on February 27, 2018; and

- WHEREAS, since it has been some time that the remaining improvements, which were approved under the initial site plan approval, have not been completed, it is important that JMA Landscaping perform and complete all remaining roadway and site improvements, in a timely manner. To ensure that the improvements are completed in a timely manner, a schedule must be submitted for the performance and completion of said improvements to the Township within 14 days of the adoption of this resolution. The schedule must be acceptable to the Township.
