MEETING OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF BERLIN, CAMDEN COUNTY, NEW JERSEY AT BERLIN TOWNSHIP MUNICIPAL HALL FEBRUARY 14, 2022 AT 5:30 P.M.

(Meeting was held by telephone due to Coronavirus)

Mayor Magazzu opened the meeting and stated that pursuant to the requirements of the Open Public Meetings Law, notice of this meeting was advertised in the Courier Post, Record Breeze and posted on the bulletin board.

All in attendance joined in the Salute to the Flag.

DEPARTMENTAL REPORTS

ENGINEER'S AND DIRECTOR'S REPORT

1. CHANGE ORDERS AND VOUCHERS

1. DEMOLITION OF BUILDINGS AT 176 BATE AVENUE AND 191 MCCLELLAN AVENUE

We recommend that the Governing Body consider approving the change order, increasing the contract by \$1,500.00 for the emptying, removal and disposal of the heating oil tank, which was located in the basement of 191 McClellan Avenue. The adjusted contract amount is \$43,300.00. After the change order is approved, we recommend full payment to the contractor be approved by the Governing Body.

2. ORDINANCES AND RESOLUTIONS

1. SHARED SERVICES AGREEMENT WITH CHERRY HILL TOWNSHIP

I recommend that the Governing Body consider passing a resolution authoring the participation into the Cherry Hill Township Cooperative Pricing System. If accepted by

Cherry Hill Township and New Jersey, the Township will be able to use the prices, received by Cherry Hill Township for traffic signal services and roadway repair services.

2. SOLID WASTE DISPOSAL SERVICES THROUGH THE CAMDEN COUNTY CO-OP

The County has authorized the extension of the contract with Covanta Energy for the option year 2022 for the solid waste disposal at the unit price of \$86.47/ton. I recommend that the Governing Body consider passing a resolution and taking all necessary action to authorize the participation in the extension of the contract with Covanta for 2022.

3. IMPROVEMENTS TO McCLELLAN AVENUE AND KRUMM AVENUE- SURVEYING AND CAD SERVICES

I recommend that the Governing Body consider authorizing Key Engineers, Inc to perform the surveying services and CAD for these projects so that I can perform the design and prepare the construction documents. The construction for these projects is being funded by the N.J.D.O.T. Municipal Aid Program.

4. <u>AMENDING ORDINANCE FOR THE REVISED PINELANDS STORMWATER MANAGEMENT</u> REGULATIONS

In the near future, I recommend that the Governing Body consider introducing the amending ordinance for the amended Pinelands Area Stormwater Management regulations.

5. REQUEST FOR THE RELEASE OF THE PERFORMANCE GUARANTEES FOR ROADWAY AND SITE IMPROVEMENTS FOR THE MONTBELLO DEVELOPMENT, SECTIONS 5 AND 6

The Township consulting inspector has emailed me a listing of corrective work, which must be performed to allow for the release of these guarantees. Therefore, I recommend that the performance guarantees not be released, at this time.

6. REQUEST TO RELEASE PERFORMANCE BOND FOR WALMART SUPERSTORE

Due to the unsatisfactory conditions I continue to recommend that the bond not be released to Walmart.

3. ENGINEER'S REPORT

1. IMPROVEMENTTS TO CLARENCE AVENUE, N.J.D.O.T FY18 MUNICIPAL AID FUNDING

The paperwork for the closeout of the project and final reimbursement of N.J.D.O.T funds have been submitted to the N.J.D.O.T Local Aid Office. I am hopeful that the paperwork will be accepted by the N.J.D.O.T and the final reimbursement check is sent to the Township.

2. IMPROVEMENTS TO SPRUCE AVENUE, N.J.D.O.T FY19 MUNICIPAL AID FUNDING- \$150,000

The N.J.D.O.T has requested that the Township closeout this project. I have been informed by the Township Consulting Inspector that the Contractor will be completing the remaining corrective work in early Spring, 2022. Therefore, the project cannot be closed out with the N.J.D.O.T until the corrective work is satisfactorily completed and final payment is made to the contractor.

3. IMPROVEMENTS TO DAY AVENUE- ROUTE 73 TO CLOVER AVENUE, N.J.D.O.T. FY20 MUNICIPAL AID FUNDING

On October 25, 2021, the Governing Body awarded a contract to Gerald A. Barrett, LLC of Berlin, N.J. for \$145,804.92 for the Base Bid and Alternate No. 1. A preconstruction meeting will be scheduled, soon, and construction is anticipated to commence in the Spring, 2022. This project is being handled by the consulting project engineer.

4. IMPROVEMENTS TO MCCLELLAN AVENUE- HADDON AVENUE TO KRUMM AVENUE (N.J.D.O.T FY 2021 MUNICIPAL AID FUNDING- \$235,000) AND IMPROVEMENTS TO KRUMM AVENUE- MCCLELLAN AVENUE TO FRANKLIN AVENUE (N.J.D.O.T FY 2022 MUNICIPAL AID FUNDING- \$275,000)

I recommend that these projects be bid and awarded as one project since they are connected to each other. I strongly recommend that the Governing Body consider authorizing the consulting project engineer to perform the necessary surveying and CAD work so I can perform the design and prepare the bid documents for an award of contract and, hopeful, construction in 2022. A contract for the improvements to McClellan Avenue must be awarded by November 2022 and for Krumm Avenue by November, 2023.

5. N.J.D.O.T FY 2023 MUNICIPAL AID GRANT PROGRAM

Typically, applications must be submitted by the end of June, each year. I recommend that the Governing Body begin to consider possible projects for submission of an application. I would be glad to submit a list of streets to the Governing Body for review for selection.

6. CAMDEN COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT (C.D.B.G.) FUNDS

The Camden County Office of Community Development has informed the Township that there are \$42,298.57 of remaining funds, which must be expended immediately. The past C.D.B.G. funds have been utilized to improve the Senior Citizens Building on Pine Avenue. A request has been submitted to the County to use the remaining C.D.B.G funds, which will be supplemented with Township funds, for the construction of a solarium addition to the Senior Citizens Building. If approved by the County, the solarium will be ordered and erected by the Township Public Works staff.

7. NEIGHBORHOOD PRESERVATION PROGRAM

a. Welcome Sign at Haddon and Luke Avenues

It is anticipated that KC Signs & Awnings will be installing the LED and sandblasted signs once they receive the necessary components.

The extension of the irrigation system and installation of the landscaping, around the base of the sign, will be performed in the Spring, 2022.

b. LED Sign at Holiday Island

We have requested a proposal from the sign vendor for this work.

c. <u>Demolition of Buildings at 176 Bate Avenue and 191 McClellan Avenue</u>

The buildings at 176 Bate Avenue and 191 McClellan Avenue have been demolished and removed from the respective sites. The former basement areas have been filled and leveled off. I recommend that the Governing Body consider approving Change Order Number 1 for the emptying, removal and disposal of the heating oil tank from the basement of 191McClellan Avenue for an additional \$1,500.00.

d. Seasonal and Holiday Banners for Haddon Avenue and Walker Avenues

The new banners have been delivered to the Township. The Spring banners will be

installed, along with new brackets, in the beginning of Spring, 2022.

e. <u>Decorative Poles and Over-the-Street Holiday Decorations</u>

We are in the process of finalizing the pole height and necessary electrical work as the work must be performed by the Township with a master meter provided by Atlantic City Electric.

f. Improvements to Irrigation Well at Luke Avenue Recreation Complex All work has been completed.

8. CAMDEN COUNTY OPEN SPACE AND RECREATION ENHANCEMENT GRANT PROGRAM

Typically, the submission deadline for applications is March 31 of each year. This is a competitive grant program, based on the merit of the project and, typically, limited to a maximum grant amount of \$25,000.00. As part of the application, the Governing Body must adopt a resolution of support. It is, also, beneficial if letters of support for the project are obtained from residents and local civic groups and organizations. I recommend that the Governing Body consider applying for this grant. I would be glad to submit a list of possible projects for review and selection by the Governing Body.

One possible project for consideration, which was pointed out by the N.J. Green Acres

One possible project for consideration, which was pointed out by the N.J. Green Acres Inspector, in 2020, is the reconstruction of the surface of the basketball courts at Luke Avenue Recreation Complex.

9. NEW JERSEY I-BANK FINANCING PROGRAM

This program provides low-interest loans for transportation and water/sewer/stormwater infrastructure project. I-Bank is partnering with the N.J.D.O.T for transportation projects and N.J.D.E.P for the water, sewer and stormwater projects. The I-Bank loan is available to supplement any shortfall in funding, for eligible projects, from the N.J.D.O.T and N.J.D.E.P. It is expected that The Federal Infrastructure Investment and Jobs Act funding will be administered through the I-Bank.

10. POSSIBLE AMENDMENT TO THE INTER-MUNICIPAL SEWER AGREEMENT WITH VOORHEES TOWNSHIP

In mid-2020, a tele-meeting was held with representatives of the Camden County Municipal Utilities Authority (CCMUA), Berlin Township and Voorhees Township to discuss the possible amendment to the current sewer agreement. Generally, the terms of the amendment to the agreement would be that Berlin Township would permit approximately 13,200 gallons/day of sanitary sewer flow from those vacant lots and lots with septic systems within a designated portion of Southwestern Voorhees Township to connect to the Berlin Township sewer collection system with the actual sewer flow allocation being assessed against the Voorhees Township sanitary sewer allocation. Berlin Township will collect the sewer connection fees and receive the annual sewer fees for these Voorhees connections. The Governing Body was acceptable to this proposal since the collection system has adequate capacity to handle the anticipated, additional flow from these lots.

11. REQUEST FOR INCREASE IN SANITARY SEWER ALLOCATION

The Township requested that the CCMUA consider endorsing the request to increase the sewer allocation to cover the flows for future development within the Township. The approval of the increase in the allocation must, eventually, be granted by the N.J.D.E.P. I

believe that the CCMUA has determined that there is sufficient remaining allocation to handle the immediate future development. This matter may need to be revisited after the anticipated development, in the immediate future, has been constructed.

12. SOLID WASTE DISPOSAL

The Township will be participating in the 2022 option year of the County Co-Op contract with Covanta Energy at \$86.47/ton. The County will be receiving bids in 2022 for participating municipalities for the upcoming five years. Everyone is hopeful that these bids will result in the most cost-effective disposal costs for the participating municipalities.

13. CAMDEN COUNTY RECYCLABLES PROCESSING CONTRACT

The current County Co-Op contract expires the end of April 2022. It is expected that the unit price for processing recyclables will increase from the current price of \$5.00/ton to \$85 to \$140/ton. This increase in cost must be considered for the budgets for 2022 and future years. I believe that the County is currently soliciting bids for these services and will be informing the municipalities of the bid results, once received.

14. CHERRY HILL TOWNSHIP COOPERATIVE PRICING SYSTEM

Cherry Hill Township is offering participating in their Co-op to municipalities and other governmental entities for the purchase of various items through their cooperative. In the past, Berlin Township has participated, and wishes to continue to do so, in the services for traffic signal maintenance and emergency repairs. Cherry Hill is, now, contracted for emergency road work. I recommend that the Governing Body consider adopting the resolution to participate in the Cherry Hill Co-Op. Once approved by the Chery Hill Township Governing Body for participation in this Co-Op, the NJDCA must approve participation by Berlin Township. There is no requirement, but just the option if needed, for Berlin Township to use the services through this Co-Op.

15. ENVIRONMENTAL CLEANUP OF COMMERCIAL SITES

a. <u>C&M Motors Site</u>, 152 Haddon Avenue

It is my understanding, that the current property owner has, again, requested that the Governing Body consider the Township taking ownership of the property and request funds for the environmental testing and cleanup of the site. I believe Mr. Platt has responded to the property owner.

b. <u>US Gas Service Station Site</u>, 170 N. Route 73

The site has been excavated, leaving the fuel supply lines and underground tanks exposed with the excavated soil and broken concrete piled on the ground surface. Mr. Shellenberger has contacted the owner and contractor to complete this work. I have been informed by the N.J.D.E.P representative that they are dealing with the owner, regarding this and other sites, within the State. They expect to issue an Administrative Order and Notice of Penalty Assessment, which will order the owner to complete the removal under a specified period. The N.J.D.E.P representative will be visiting the site, soon, to determine if there is any product within the underground tanks.

16. MONTEBELLO AGE-RESTRICTED RESIDENTIAL DEVELOPMENT

a. Corrective Work and Completion of Various Improvements

I have met with representatives of the developer, on January 13, 2022, to discuss the performance of the corrective and remaining roadwork and site improvements, throughout the development.

I will be performing an inspection of the concrete sidewalk driveway aprons, granite curbing and other roadway improvements and updating my report, soon. I will, also, be inspecting the perimeter buffer area with the developer, along Voorhees Township to determine the placement of infill evergreen plantings.

The developer will, also, be submitting a letter to the Township to address the matter of the landscape plantings along the commercial lot.

b. Meeting with Representatives of the Homeowners Association

I have met with representatives of the Homeowners Association to discuss the findings from their consulting engineers, regarding corrective work throughout the development. They have informed me that they have discussed various corrective work with the developer and working towards an agreement. I will be reviewing their consultant's reports against the design documents and will respond to the Homeowner's representatives.

c. Request for the Release of the Site Improvements Bonds for Sections 5 and 6 The Township consulting inspector has informed me that corrective work must be performed for several of the improvements, which are covered by these bonds. Therefore, at this time, I recommend that the bonds not be released by the Township.

17. REVIEW OF TOWNSHIP ZONING AND LAND DEVELOPMENT CODES

The Township Professional Planner will be working with the Township officials and staff to review and update the zoning and land development codes. The Planner and I participated in a zoom conference with representatives of the Pinelands Staff to discuss the possible redesignation of Pinelands areas, within the Township. The Planner will be reviewing other areas and zoning districts, within the Township, and submitting the recommendations in the future. I have met with the Planning Board Chairperson and Zoning Officer to discuss possible updates to the zoning and land development standards. Once completed, we will submit our recommendations to the Planner for review and consideration before submitting them to the Planning Board for their review and consideration for recommendations to the Governing Body. The Zoning Map will, also, be reviewed for updates. I have recommended that zoning district lines be adjusted to follow lot lines to eliminate split zoning on lots, where possible.

18. AMENDED PINELANDS STORMWATER MANAGEMENT REGULATIONS

The Governing Body adopted an ordinance to amend the stormwater management requirements for the non-Pinelands area within the Township to be consistent with the recently amended NJDEP stormwater regulations. The Pinelands Commission has, recently, amended their stormwater rules for the areas within the Pinelands Area, to be more consistent with the recently amended NJDEP regulations. It is my understanding that the Pinelands amended rules became effective on January 18, 2022 and the Township has one year to incorporate the new rules into the master plan and land use ordinances. I recommend that the Governing Body consider authorizing the necessary work to address this matter.

19. STORM DRAINAGE IMPROVEMENTS

a. <u>Lester Avenue Drainage and Stormwater Management Facility at the Low Point</u>

We have not completed the design for this project.

I intend to complete the design for a reduced scope of work, based on the amount of the funds for this project.

b. Kelley Drive Basin Improvements

No update to report.

c. Mt. Vernon Avenue at the Elementary School

No update to report.

d. Storm Drainage Improvements, Southwest Portion of the Township

No update to report.

20. STUDY FOR DESIGNATED TRUCK ROUTES THROUGHOUT THE TOWNSHIP

This work remains to be completed and the recommendations submitted to the Governing Body for consideration for adoption.

21. AMENDMENTS TO CHAPTER 280, SOLID WASTE

I recommend that the Governing Body consider amending this code to be consistent with current policies and practices. I will submit my recommendations to the Governing Body for your consideration.

22. IMPROVEMENTS TO THE PUBLIC WATER DISTRIBUTION SYSTEM WITHIN THE TOWNSHIP

I continue to recommend that the Borough consider interconnecting/looping all dead end and upgrading all undersized water mains throughout the Township. At this time, I am not aware of the Borough proposing any improvements to the system, within the Township.

A. PUBLIC WORKS DEPARTMENT

1. OPERATIONS AND STAFFING

The staff continues to perform the winter season tasks and will be preparing the necessary equipment for the Spring and Summer seasons.

The staff continues to practice safe COVID-related practices.

If determined to be necessary, the Department will attempt to hire seasonal employees for the upcoming Spring, Summer and Fall Seasons.

The Mayor and Chief Financial Officer are finalizing the negotiations of the contract with the Public Works Employees Association representatives.

2. UPDATING THE VEHICLE FLEET AND EQUIPMENT

Due to the current nationwide shortage of trucks available for purchase, the delivery of the new pick-up truck is delayed. Mr. Simone has been working with vendors to purchase a new rear load trash truck, small dump trucks and leaf collection machine.

It will be necessary to begin performing repairs and replacement of components of the automated arms on the side-load trash trucks, in the immediate future.

3. REQUEST FOR CAPITAL IMPROVEMENTS AND PURCHASES

The Governing Body and Chief Financial Officer are reviewing our request for the capital improvements and purchases for the highest priority items. We would be glad to discuss these requests with the Governing Body and Mr. Davidson, in further detail.

4. IMPROVEMENTS AT THE PUBLIC WORKS COMPLEX

Last year, sliding gates were installed to replace the original gates and the fuel dispensing system was upgraded. There is an immediate need to replace the roof shingles for the garage building, which must be performed in 2022.

SOLICITORS REPORT

Stuart Platt commented that he has submitted his report to the Governing body.

POLICE REPORT

Dear Mayor and Council,

- 1. Beginning January 1st 2022 Berlin Township Police Officers began wearing the newly purchased Body Worn Cameras. A policy was set into place and notification was posted via the website and social media as per the AG Guidelines. Feedback thus far has been all positive. Police interactions with the public will now be recorded both audio and video. This will assist our department in many facets of law enforcement and also further enhance transparency with the public as a Police Department.
- 2. Berlin Township Police have recently changed uniforms. The shirt color was changed from a French blue to a dark navy blue. Also, patrol officers are now equipped with body armor outer carriers. The feedback from residents and citizens has been overwhelming supportive commenting how sharp our new look Officers appear. The vest carriers also allow for a weight distribution transfer for Officers thus supporting long term Officer Wellness. I wanted to give a special thank you to Mayor and Council for supporting our new look and helping us find the right fit our Officers and what is best for our community here in Berlin Township.
- 3. Catalytic Converter thefts from a motor vehicle continues to be a problem throughout not just the town but also the State of NJ. Most of these thefts are occurring while vehicles are parked in business districts during the evening hours. Businesses can assist the police by turning on exterior lights at night

especially when the business is closed. Also, please make sure camera systems are functioning properly to assist with identifying suspects and their vehicles. We have made prior arrests in regards to catalytic converter thefts in town but the scrap metal material is in high demand causing multiple people to commit the act.

- 4. Berlin Township Police arrested 2 adults for DWI during the month of January and one involved a crash. We have applied for grant money through the County for extra roving patrols specifically to seek motorists who are driving while impaired. We implore drivers to use other means of transportation if consuming alcohol such as an Uber, Lyft, Taxi, or simply phoning a friend or relative. As a reminder, a crash involving an impaired driver causing injury to another, not just injures an innocent motorist but also results in a criminal offense as assault with a Motor Vehicle.
- 5. A new business owner applied for a mercantile License in Berlin Township. The business is located at 231 First Avenue under the name of Ermilio Plumbing. A background check was completed and the police department would recommend to the governing body to approve the license.

PROPRTY MAINTENANCE / ANIMAL CONTROL

Josh Schellenberger commented that the Rabies Drive Through Clinic was held on Saturday January 22, 2022 and that we had administered 109 Vaccinations.

FIRST READING ORDINANCE 2022-1 AN ORDINANCE OF THE TOWNSHIP OF BERLIN, COUNTY OF CAMDEN, NEW JERSEY, APPROPRIATING \$1,400,000 FOR THE ACQUISITION OF VARIOUS VEHICLES AND PIECES OF CAPITAL EQUIPMENT AND TOWNSHIP IMPROVEMENTS.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BERLIN, COUNTY OF CAMDEN, STATE OF NEW JERSEY AS FOLLOWS:

Section 1. There is hereby appropriated the sum of \$1,400,000 from the General Capital Improvement Fund for the acquisition of vehicles and various pieces of

capital: (i) \$150,000 for the acquisition of police vehicles and equipment including but not limited to patrol vehicles and vehicle upfits; (ii) \$750,000 for various public works vehicles and various pieces of capital equipment including but not limited to 4X4 pickup trucks and snow plowing equipment; (iil) \$500,000 for Various Township improvements including but not limited to municipal building sign improvements and senior center improvements together with the acquisition of all materials and equipment and completion of all work necessary therefore or related thereto (collectively, the "Project").

Section 2. It is hereby determined and stated that the Project set forth in Section 1 is a general improvement and is not a current expense of the Township.

Section 3. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with Township Clerk and available for inspection.

Section 4. All ordinances or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This ordinance shall take effect after final adoption and publication as required by law.

Notice is hereby given that the foregoing Ordinance was introduced and passed upon first reading at a meeting of the Mayor and Council of the Township of Berlin, Camden County, New Jersey on February 14, 2022 and the same was ordered published pursuant to statute. Said ordinance will be further considered for final adoption at a meeting of the Mayor and Council of the Township of Berlin on March 14, 2022 at 5:30 p.m. prevailing time in the Municipal Building, 135 Route 73 South, West Berlin, NJ or by virtual teleconference.

Motion by Councilwoman Bodanza, second by Councilman Epifanio to adopt Ordinance 2022-1 on first reading by title. Ordinance adopted by call of the roll, four members present voting in the affirmative.

FIRST READING ORDINANCE 2022-2 AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A.40A:4-45.14)

WHEREAS, the Local Government Cap Law, <u>N.J.S.A.</u> 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 1% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Mayor and Council of the Township of Berlin in the County of Camden finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council hereby determines that a 1.0 % increase in the budget for said year, amounting to \$81,413.81 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Council of the Township of Berlin hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Township of Berlin, in the County of Camden, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Township of Berlin shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$284,948.34, and that the CY 2022 municipal budget for the Township of Berlin be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

RESOLUTION 2022-69 RESOLUTION AUTHORIZING CERTAIN REAL PROPERTY LOCATED IN THE TOWNSHIP OF VOORHEES TO CONNECT WITH AND DISCHARGE ITS SEWAGE INTO THE BERLIN TOWNSHIP SEWAGE SYSTEM

WHEREAS, properties located in Voorhees Township at Block 286, Lot 2 with an address of 3 Second Avenue, Voorhees, New Jersey and Block 287, Lot 8 with an address of 28 Lafayette Avenue, Voorhees, New Jersey are currently on septic systems which have failed and it is not feasible to be repaired or replaced ("Properties"); and

WHERAS, the Properties are currently not connected to the Voorhees Township Sewage System and there is no portion of the Voorhees Township Sewage System which is proximate to the Properties; and

WHEREAS, the owners of the Properties have requested special consideration to allow them to discharge the sewage from the Properties and connect into the Berlin Township Sewage System because their septic systems have failed and are not feasible for repair or replacement; and

WHEREAS, the Township Engineer has reviewed this matter and due to the public health emergency being suffered by the owners of the Properties has recommended it

would be appropriate to allow those Properties to discharge their sewage and connect into the Berlin Township Sewage System subject to the conditions set forth below.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Council of the Township of Berlin, County of Camden and State of New Jersey as follows:

- 1. The owners of the Properties are hereby authorized to discharge their sewage and connect into the Berlin Township Sewage System in accordance with the conditions set forth herein.
- 2. The owners of the Properties shall be responsible for all engineering and costs of installing and connecting into the Berlin Township Sewage System and Berlin Township shall have no responsibility or liability for any costs associated with same.
- 3. The owners of the Properties shall submit an application to the Township which shall review and consider the discharge of sewage from the Properties and connection into the Berlin Township Sewage System in accordance with Township regulations and all other regulations governing the discharge of sewage into a public sewage system.
- 4. In the event the Township approves the sewage connection from the Properties into the Berlin Township Sewage System, the owners of the Properties and their successors and assigns shall be responsible to permanently pay any and all sewer connection fees and sewer charges to Berlin Township at the then current rates as other Berlin Township property owners pay.
- 5. This Resolution is subject to approval by the Camden County Municipal Utilities Authority and all outside agencies.

- 6. By making application to Berlin Township, the owners of the Properties do so at their own risk, cost and expenses and shall comply with Berlin Township's rates, rules and regulations for making said connection including, but not limited to application procedures, permitting, construction procedures and specifications, payment of escrow and inspection fees, connection fees and all other requirements of Berlin Township necessary to approve the connection into its sewage collection system. The responsibility of constructing these facilities shall be on the owners of the Properties.
- 7. At all times hereinafter, any sewer laterals that connect into the Berlin Township Sewage System shall remain the responsibility of the owners of the Properties.
- 8. The owners of the Properties shall be responsible for payment of any annual sewage charges as well as any other charges imposed by the Camden County Municipal Utilities Authority for treatment and disposal of sewage in connection herewith. The Township of Berlin has no responsibility and/or liability with regard to these charges which are billed separately and apart by the Camden County Municipal Utilities Authority.
- 9. It is agreed and understood that Berlin Township shall not be under any obligation to the Properties to alter, enlarge, extend or in any respect change the whole or any portion of its sewage collection system.
- 10. The owners of the Properties and their successors and assigns agree to indemnify, defend and hold harmless Berlin Township from and against any and all claims or damages to persons or properties including reasonable attorney's fees which Berlin Township may reasonably suffer, expend or incur as a result of this authorization and/or the construction of the sewage facilities described herein.
