BERLIN TOWNSHIP CAMP OUT RULES & REGULATIONS

- * BERLIN TOWNSHIP RESIDENTS ONLY!
- * A PARENT AND OR GUARDIAN MUST BE PRESENT AT ALL TIMES.
- * NO RV PERMITTED...TENTS Only. All participants MUST bring their own tent.
- * NO GRILLS. Food will be provided for this event at NO CHARGE.
- * Alcoholic beverages and smoking ARE NOT permitted.
- * Generators ARE NOT permitted.
- * TOWNSHIP Bathrooms will be available.
- * All camp sites shall remain clean and clear of debris at all times.
- * The TOWNSHIP will provide the Camp Fire.
- * Items you MUST bring: Tent(s), sleeping bag warm clothing and lawn chairs.
- * Dogs ARE NOT permitted unless proof of service dogs with proper ID is provided.
- * Out of respect for all participants, noise should be kept at a minimum.
- * All campers Must be set up between 4:00 pm to 6:00 pm.
- * All campers MUST be packed up, area cleaned by 10:00 am on September 29, 2024.
- * The TOWNSHIP is not responsible for stolen or lost property.
- * Police and Fire will be present periodically for the duration of the event.

Cancellation of Event

The Township reserves the right to cancel the event due to adverse weather conditions. The Township shall notify all pre-registered participants of cancellation by 12:00 p.m., on Saturday, September 28, 2024. If adverse weather occurs during the event, the Township may cancel at its discretion.
